Dear Chairman Cole and Ranking Member DeLauro:

I am requesting funding for the **Old Town Infrastructure Enhancements Project** in Fiscal Year 2026. The entity to receive funding for this project is **the City of Placentia**, located at **401 E Chapman Avenue, Placentia, CA 92870**.

The funding would be used to modernize infrastructure, improve accessibility and enhance overall working conditions for law enforcement personnel. The City of La Palma is submitting a Community Project Funding request in the amount of \$2,000,000 to fund infrastructure improvements including utility upgrades, undergrounding of overhead utilities, street improvements, pedestrian and active transportation connectivity and facilities, and landscaping and lighting upgrades. The project is an appropriate use of taxpayer funds because the project will provide a sustainable, long-term funding mechanism for essential public infrastructure improvements – without imposing new taxes or fees on property owners.

The project has a federal nexus because the funding provided is for purposes authorized by 42 U.S.C. 5305(a)(1), 5305(a)(2), 5305(a)(4), and 5305(a)(5).
